Update on the Tena Gallagher Research & Projects Grant #4353: Through the generosity of our Danville-Alamo-Walnut Creek Branch members and the proceeds of our 2010 Garden Tour, we have been able to donate \$19,800 towards the **\$75,000 Tena Gallagher R&P Grant in 2010. What an amazing achievement for a grant only in existence since last July!! Kudos and Thanks.**

CALIFORNIA-A STATE IN SEARCH OF NEW REVENUE

In this period of dire economic need, the state of California is now anxiously searching for any new sources of revenue. Here is just one of the many suggestions citizens are putting forth. Many citizens and experts are wondering why this oil rich state has never had an oil severance tax. California is among the highest-volume oil producing states in the country. The California oil companies extract oil and gas from under land and water without paying any royalties. Most oil rich states do have such a tax. Alaska has an extra generous oil profits tax that even benefits each of its citizens monetarily. The federal government also gets an 18.75% royalty from waters just ten miles off the California coast.

In 2006, Proposition 87, which included an oil severance tax, was defeated by Chevron and other big oil companies in a massive campaign. But this is now, and as California comes to grips with its deepest revenue needs ever, it must stand up to Big Oil to demand this tax.

California faces a \$25.4 billion budget gap for the 2011-2012 fiscal year, and fixing the budget problems will not be accomplished in a single year, or perhaps several years. However, by chipping away now, the state must begin this serious and painful process. The big oil companies of California pay less than ordinary state corporate taxes now, and their property taxes are limited under Proposition 13, so a severance tax, similar to those of other oil rich states, would not make drastic inroads into their immense profits. It is time for the California legislature to see that this happens and pull out all the stops to make this appeal to California voters. Against the might of the oil lobbying effort, with all their millions, the voters must understand and be willing to pass this legislation.

The new Governor of California has had to make many painful cuts into education, health and social services; extend sales, income and auto taxes for five more years; and shift some programs to local governments in his new budget proposals. Its ramifications will be felt by all of us. With cooperation among members of the California Legislature, the special election in June will begin the process. ❖

Remember the Ladies!" the battle cry of California's suffragists will be heard again when members of the Museum of San Ramon Valley re-enact women achieving the right to vote in California 100 years ago. The local 45-minute historical drama will be held during the general membership luncheon **Saturday, March 12** from 11-3 P.M. at Crow Canyon Country Club, 711 Silver Lake Drive, Danville.

This centennial program will highlight local women of the San Ramon Valley and early 19th and 20th century suffrage movements which accomplished this historic feat. California's vote in 1911 pioneered passage of the 19th Amendment on women's voting rights nationwide. AAUW is recognizing this achievement by early California women nationally and statewide.

This local presentation kicks off a *Remember the Ladies* exhibit set to run May to June at the Museum of the San Ramon Valley.

Registration and social hour begin at 11 A.M. General Meeting and luncheon start at Noon followed at 1:30 p.m. with the "Remember the Ladies!" performance.
