Financial Report:

- New member welcome event needed, no plan yet. One already held, but low attendance

Programs:

- November program: draft flyer distributed
 - Suggestions for improvements provided
 - Provide additional suggestions to Deborah Wechsler
 - Flyer will be revised with input from Dora-Thea Porter
- December social: like last year, primarily a social event
- January program: No candidates' forum, no interest from League of Women Voters. Ballot initiatives only
- February program: Tena will talk with Bette about marketing WorkSmart with our 3 Danville town council members
- Lynn Goodwin has volunteered to give a writers' workshop
 - \circ $\;$ Branch education, not specifically a National strategic direction
 - \circ $\;$ Issue: whether or not it would appeal to a wide section of our membership
 - Could be paired with poetry writing led by another member, for a 1-day program
 - Suggested that Writer's Group take ownership of this potential program, Asha Bajaj will review the idea with Bette Felton

50th Anniversary Update:

- 81 reservations so far, contract commitment for 160
- Trying to renegotiate contract with Crow Canyon Country Club
- Issues: Price too high, low guest signups, reluctance to attend evening events, driving issues
- Send another member email blast, include that car pools will be organized for those unable/reluctant to drive Claudia will organize
- Tena will check with Cindy Silva (WC mayor) about attending, speaking

Fundraising Proposal:

- Committee members: Tena Gallagher, Chris Ritter, Bette Felton
- This proposal will require further work, discussion within the branch, and approval:
 - The Garden Tour will continue
 - This will be our last year for the HHT it has become too difficult to get homes
 - Next year we will try an architectural tour in the fall
 - Anticipate that homes will be easier to arrange and builders can contribute

- We must finish our 45th Anniversary fellowship fund within a couple of months, based on current financial status provided by National AAUW Fund
 - This fund needs to be completed in order for the funds to be provided for fellowships
 - Tena will send this latest financial information on our status to Robin Halloran and Liz Williams
- Going forward, our 2 tours will fund our local scholarships and Tech Trek
 - No future funding of AAUW Fund or creation of a branch educational fellowship
 - Funds will provide benefit to our communities
 - Question: What to do if our tour brings in more money than Tech Trek needs
- Individual contributions will continue to be solicited for AAUW Fund
 - Donations to the areas of greatest need will be stressed
 - Educational areas are over-funded and the monies can't be transferred to other areas of need

Chamber of Commerce Proposal Update:

- Chris Ritter, Elle Bonner, and Deborah Wechsler met with the Chamber of Commerce to learn more
- Handout with status reviewed
- Issue raised about whether the missions of the organization and/or its members align or conflict with ours
 - Chris, Elle, and Deborah will look into current nonprofit members to learn more about their organizations, strategic directions, and how membership is working out for them.
 - They will also check with Teresa Cheung, who owns Montecatini in W.C. and any other branch members who may have a business with the Chamber
 - Board members encouraged to check with anyone they might know about these questions

Holiday Home Tour Status:

- Have 5 homes, another would be nice because the 5th home is small
- Looking for head docents
- Work on the post card, flyer, and ticket is underway
- Will advertise this as our last holiday tour, give a save-the-date for our first architectural tour next year

AAUW Funds:

- Solicitation letter almost complete, needs to be modified with latest financial status from National
- Solicitation letters will be mailed and emailed

Tech Trek:

• Donations to date: \$2308, enough for 2 girls

- Signed up for 12 girls, unlikely we will be given that many spots
- Applied for a Walnut Creek grant of \$2,000, enough to fund 2 girls

Local Scholarships:

- A treasurer is needed, since our local scholarship program is now set up as 501(c)3 with an SPF
- A committee is needed
- Liz and Robin will review last year's scholarship committee changes with Nancy Murray and assist with finding committee members
- Nancy will request a list of members interested in supporting our scholarship work from Joanne Quijano

Other Business:

- IBC will be added as a standing agenda item
 - o IBC focus is on providing more assistance to branches
 - Public Policy direction and support: AAUW state wants every branch to identify a Public Policy chairperson
 - Education: AAUW state also wants every branch to identify an Education Liaison
 - IBC will push back on this and work with state to have a Liaison at the IBC level
 - Within our county, it doesn't make sense for each branch to try to work with local colleges independently
 - Deborah will discuss involvement in Chambers of Commerce with the IBC
