
and for Congresswoman Ellen Tauscher. She is a Bay Area native and lives in Oakland with her husband and two young children.

#### COVID couldn't keep us down!




Thanks to the phenomenal support of the camp directors, committee members, branch coordinators, schools, and the AAUW California leadership team, we have been able to deliver another successful season of Tech Trek camps in California. So many challenges and potential obstacles were thrown in our path this year, from COVID-19 to a new database, and once again all the branch coordinators and volunteers rose to the challenge! From the first in-person camp orientation on June 12th to the virtual camp Closing Campfire on July 29th, we successfully served 639 campers from 94 branches at eight camps (six residential, two virtual) across California, staffed by a community of 230+ volunteers, over half of whom were Tech Trek alumnae!

A focused team, led by Co-President Chris Ritter, has reviewed the requirements to make this change and has revised our Bylaws and Standing

Rules accordingly. They have also created Articles of Incorporation for the branch to become a corporation along with the change to a 501(c)(3). We now need a membership vote to approve these documents.

## Board strategy session report - Make a Difference!

The branch board members embraced our theme for this year – *Make a Difference* – at our strategy session in August. We plan to build on the AAUW mission of advancing gender equity for women and girls by creating and supporting programs and initiatives to inform, to educate, and to facilitate activities that will enable us to make a difference in our local community. We will aim to tap into our members' desire to be active and get involved.

To set the branch's direction for the coming year, we started by identifying a range of ideas and topics of interest within three strategic areas - economic equity, social justice, and women's health/reproductive rights. Once identified, we narrowed our focus for this year's efforts by voting on the top five topic areas to address.

These top five topic areas for this year are:

- Women in Power
- Education Equity
- Title IX
- Foster Care
- Women's Health and Reproductive Rights

These key focus areas will inform our speakers' programs at the Third Thursday meetings as well as direct and inspire other branch activities throughout the coming year.

Getting out the vote is a big push this November to ensure our democracy is strong and that all Americans can make their voices heard. # **Public Policy Updates**

#### Learn about the Inflation Reduction Act



The Inflation Reduction Act of 2022 (IRA) is a United States law which aims to curb inflation by reducing the deficit, lowering prescription drug prices, and investing in domestic energy production while promoting clean energy. It was signed into law on August 16, 2022. It is a budget reconciliation bill sponsored by Senators Chuck Schumer (D-NY) and Joe Manchin (D-WV). The bill was the result of negotiations on the proposed Build Back Better Act, which was reduced and comprehensively reworked from its initial proposal after receiving opposition from Manchin. It was introduced as an amendment to the Build Back Better Act and the legislative text was substituted.

The law will raise \$737 billion and authorize \$369 billion in spending on energy and climate change, \$300 billion toward deficit reduction, three years of Affordable Care Act subsidies, prescription drug reform to lower prices, and tax reform. Some changes were made to the tax provisions after negotiations with Senator Kyrsten Sinema (D-AZ). The law represents the largest investment in addressing climate change in United States history. According to several independent analyses, the law is projected to bring the U.S. significantly closer to President Biden's goal of reducing greenhouse gas emissions to 50% below 2005 levels by 2030. It also includes a large expansion and modernization effort for the Internal Revenue Service.

#### California legislative updates

**Reproductive rights** - The recent US Supreme Court's Dobbs decision on abortion has stimulated action in many states across the nation, including California. Our legislature passed, and Governor Newsom signed, **AB 1666** which will enable a woman coming into California to receive an abortion to be protected from lawsuits originating in her home state. *This bill was cosponsored by AAUW CA!* 

A further step protecting a woman's right to make personal medical decisions is a Constitutional Amendment, **Proposition 1**, which will be on the November 8 ballot. It would amend the California Constitution to prohibit the state from denying or interfering with an individual's reproductive freedom in her most intimate decisions, which includes the fundamental right to choose to have an abortion and the fundamental right to choose or refuse contraceptives. AAUW CA supports this constitutional amendment.

AB 988 (Bauer-Kahan) - Mental health: 988 crisis hotline

Current federal law, the National Suicide Hotline Designation Act, designates the 3-digit telephone number "988" as the universal number within the United States for the purpose of the national suicide prevention and mental health crisis hotline system. This bill would enact the Miles Hall Lifeline and Suicide Prevention Act. The bill would require the Office of Emergency Services to ensure, no later than July 16, 2022, that designated 988 centers utilize technology that allows for transfers between 988 centers as well as between 988 centers and 911 public safety answering points. The bill would require, no later than 90 days after passage of the act, the office to appoint a 988-crisis hotline system director, among other things. The bill would require, no later than July 1, 2024, the office to ensure interoperability between and across crisis and emergency response systems used throughout the state, as described. The bill would require the office to consult with specified entities on any technology requirements for 988 centers.

**AB 1942** (Muratsuchi) - Community colleges: funding: instructional service agreements with public safety agencies.

Commencing with the 2024–25 fiscal year, AB 1942 would require instruction provided by community college districts under instructional service agreements, with public safety agencies, as defined, to be funded under the apportionment formula used for instruction in career development and college preparation. The bill would, commencing with the 2022–23 academic year, require each community college district with an instructional service

agreement with a public safety agency to annually submit a copy of its most up-to-date instructional service agreement, and beginning January 1, 2024, to annually submit specified data to the California Community Colleges Chancellor's Office.

ACR 205 (Wilson) - Women Veterans Recognition Day

This Assembly Concurrent Resolution would proclaim June 12, 2022, as Women Veterans Recognition Day and urge all Californians to join in celebrating the many contributions of women to our armed forces.

SJR 12 (Skinner) - Equal Rights Amendment

This joint resolution would urge the Congress of the United States to pass House Resolution 891, resolving that the requirements have been met to ratify the Equal Rights Amendment (ERA) and that it shall now be known as the "Twenty-Eighth Amendment to the Constitution."

**ACR 154** (Seyarto) - Women in science, technology, engineering, and mathematics

This measure would honor 100 years of women in science, technology, engineering, and mathematics during the month of June 2022.


