**Allison Kern, Director of Athletics at California State University East Bay,** will share her knowledge and perspective about the impact of Title IX on women's athletics.

Allison Kern was named Assistant Vice President/Director of Athletics in August 2021. She leads the Pioneers' 15 intercollegiate athletics program, which consist of more than 230 student-athletes competing in the California Collegiate Athletic Association (CCAA), Pacific Collegiate Swim and Dive

Conference (PCSC) and Western Water Polo Association (WWPA). She was previously the director of athletics at St. Xavier University in Chicago, beginning in July 2019. There, she increased revenues to athletics, including donor support, and co-chaired the university's strategic planning committee.

Prior to her time at St. Xavier, Kern was with Agnes Scott College in Decatur, Ga., where she served as the head women's basketball coach and later assistant director of athletics for external relations before assuming the role of director of athletics in 2018.

A former student-athlete in basketball and track and field, Kern received her Bachelor of Arts in political science from John Carroll University in Ohio.

## **Public Policy Update**

Here is a recap of the two propositions on the November ballot that are supported by AAUW. The League of Women Voters gave us a very good review of the situation, the proposals, their funding sources, and anticipated fiscal effects. AAUW recommends a yes vote on both.

#### **Proposition 1**

The Situation -The right to privacy, including the right to decide whether to give birth, has been largely eliminated at the Federal level by a recent U.S. Supreme Court decision. There is concern that the right to obtain and use contraceptives under the U.S. Constitution's implied right to privacy may also be under similar threat

Supporters Say - Prop 1 will enshrine the fundamental right to an abortion and a fundamental right to contraception in the California State Constitution. Doctors, nurses, and health providers all agree that Yes on Prop 1 is necessary to keep reproductive medical decisions where they belong—with individuals and their health care providers based on scientific facts, not political arguments.

Opponents Say - Women already have the right to choose under current California law. The recent U.S. Supreme Court ruling did not and will not change this. Prop 1 is not needed to protect women's health or their reproductive rights.

### **Proposition 28**

The Situation - Because Prop 98 passed in 1988, the California Constitution requires a minimum percentage of the state budget to be spent on K-14 education (kindergarten through two-year community college). This minimum guarantee is calculated annually. There is currently no guaranteed source of annual funding in the state budget for arts and music education in K-12 public schools. State law requires schools to provide arts and music instruction to all students in grades 1 through 6. In order to graduate, high school students must complete a year in one of three courses of study, one of which being arts and music education. Beyond these requirements, other specifics such as the amount of instruction or when courses are offered is determined by the local governing board.

Fiscal Effects - Prop 28 would increase state expenditures by about \$1 billion per year, over and above existing constitutional requirements.

Supporters Say - Arts and music education can improve a student's personal and academic life. Only one in five schools have a dedicated teacher for arts and music programs. Prop 28 does not raise taxes.

No organized opposition.

Through slides and commentary, the speakers walked us through the 7 state ballot propositions on the November ballot. They encouraged us to study and try to understand the motivations behind each proposition, as well as learning the supporters and opponents of each. There were good questions and plenty of back-and-forth conversation that was clarified and moderated beautifully by the speakers. The venue was hailed by all as a fine place to meet. It will be the regular monthly setting for our Third Thursday Member Meetings and programs. LEGISLATIVE SESSION ENDS WITH BIG SUCCESSES FOR AAUW CALIFORNIA! The 2021-22 Legislative Session officially came to a close at midnight on September 30th, the Governor's deadline for signing or vetoing bills. I'm excited to announce that 25 of our 36 bills for this year are now law – a 70% success rate! Of our six high-priority bills, five have become law. Here is a quick summary:

**Economic Security bills** 

9 signed by Governor

**Equal Access to Education bills** 

6 signed by Governor

1 approved (no signature required)

Social and Racial Justice bills

7 signed by Governor

1 approved (no signature required)

1 incorporated into Executive Order
