Writing Diverse Stories

Thursday, February 15, 2024, 6:00 pm Danville Congregational Church

Join us in February for our Third Thursday Member Meeting! In addition to our usual social time, we are fortunate to have as our guest speaker one of the AAUW Fund Fellowship recipients, K. X. Song, speaking to us via Zoom. An accomplished author, she will touch on the creative process behind her stories, the nonlinear trajectory of her publishing journey in the US, and the importance of diversity and representation in storytelling and media at large. She will also discuss the state of the US publishing industry today, and

some of the challenges particular to women of color in the industry.

Some next steps / actions to help, recommended by our speaker:

- Support marginalized authors by reading diverse literature, even if it's outside your typical genre or if it's from an author you've never heard of before. (Bonus: review your favorite books online on sites like Amazon or Goodreads!)
- Buy from independent bookstores or borrow and request books from your local library.

K. X. Song is an award-winning diaspora writer with roots in Hong Kong and Shanghai. Raised between cultures and languages, she enjoys telling stories that touch on collective memory, translation, and the shifting nature of memory and history. A Highlights Foundation Fellow and HG Wells Turnill Prize honoree, she has been awarded residencies at the Ragdale Foundation and the Anderson Center at Tower View. *An Echo in the City* is her debut novel, and her forthcoming novel, *The Night Ends with Fire*, will be released in Summer 2024 with Penguin Random House.

K.X. received her degree in Business Communications from UCLA and then was employed for four years with Meta. She is currently working on her MBA at Stanford funded through **AAUW's fellowship program**. You can visit her online at kxsong.com.

Co-Presidents' Messages

From Monika - Hi everyone, I hope you are staying dry and warm!

From my perspective, last week was a perfectly amazing week for DAW. On Tuesday, fourteen DAW members were visibly present at the SRVUSD school board meeting. Barbara Blalock and Ogie Strogatz gave thoughtful public comments; I was honored to be a part of the group. And then a few days later at our February DAW board meeting, we voted to include financial need and special circumstances (such as perhaps a first-generation college student) as additional considerations for our Local Scholarships. We also voted to establish a named scholarship with

the Diablo Valley College Foundation: American Association of University Women, Danville-Alamo-Walnut Creek Branch, (AAUW DAW) Single Parent Scholarship. A few days after that, on Saturday, a meeting at Rossmoor with a coalition of community group leaders from across Alameda and Contra Costa counties was organized by Public Policy Chair and AAUW California School Board Project Team member Laurinda Ochoa, Ogie, and others to develop a plan to protect public education. This impressive group is planning a summit for April 13. Please save the date and plan to attend. You'll hear more in the coming months.

But for today, you might ask why supporting single parent families is a good idea for AAUW DAW. According to Annie E. Casey Foundation data¹, in 2021 nearly 30% of single parents lived in poverty. Within single parent families, most children - 14.5 million - live in mother-only households. DAW will award one scholarship this year and perhaps expand in the years ahead.

We learned about the possibility of directing a portion of our Local Scholarship funds to a single parent scholarship from two contacts that our members have with members of other California AAUW branches. Ogie learned from the AAUW California DEI Chair, Charmen Goehring, that the AAUW Citrus Heights - American River Branch has a similar scholarship. Also, Chris Ritter told us about it when she researched the 501(c)(3) process, since we used some of the Citrus Heights - American River Branch's documents as examples for our own 501(c)(3) application.

I am proud of these results for Local Scholarships, and of the group that put the proposal together. Judy Lauper, Holly Sauer, Ogie Strogatz, Sarah Williams, Ann Willoughby, and I worked together for this gratifying outcome. I thank them and the DAW Board for their support. I am impressed and grateful for all the work that DAW members do in our community - with DAW, and also with other organizations.

I wish to acknowledge AAUW's recognition of February as Black History Month. I just watched the <u>AAUW California webinar</u> about Mary Church Terrell (1863-1954), who became the first Black member of AAUW after winning an anti-discrimination lawsuit. The webinar featured Dr. Alison Parker, author of *Unceasing Militant: The Life of Marcy Church Terrell*. Terrell was the daughter of enslaved parents who earned her BA and MA from Oberlin College. She was an educator, a journalist, a founding member of the NAACP, and a fierce, prominent suffragist and civil rights activist.

AAUW also has highlighted <u>Brandeis University's "Black Women as History Makers"</u> – a robust list of books and videos to help deepen our understanding.

2024 Tech Trek planning is in full swing. We're working with our local science and math teachers and already have 7th grade girl nominees from several of our local middle schools! Meanwhile, we've secured their spots at Tech Trek camps in Fresno and either Sonoma State or Santa Clara University and are in close contact with camp organizers. Next steps are to select the girls who will attend and to wrap up fundraising.

We seek volunteers to help interview the girls. The commitment would be about four hours total as part of a school interview committee, divided between interview and selection efforts focused on three girl nominees from a single school. Interviewers who participated in the past felt it was a very rewarding and fun experience helping to guide a first "interview" experience for these promising future STEM professionals and help build their confidence.

Diversity Equity and Inclusion (DEI) In Our Branch

The DEI Committee on Zoom: January 9 Meeting Highlights

At our January meeting, DEI Officer Teresa Cheung reported that the committee's unanimous support for national AAUW to drop the degree requirement for membership has been shared with our Board. (All AAUW members across the country will have the opportunity to vote this spring on whether or not to maintain the degree requirement.)

Kathie Hixon provided an update about the April branch membership meeting that the Committee will host. Our program objective is to deepen knowledge and understanding about people who identify as transgender. Taylor denBroeder and Elisa Tinker, leaders of Danville/San Ramon PFLAG (Parents, Families, and Friends of Lesbians and Gays) will lead the presentation.

The remainder of the meeting was devoted to a discussion of DEI in the context of challenges facing local school boards. Public Policy Chair Laurinda Ochoa described her experience observing San Ramon Valley Unified School District Board meetings since 2022. Laurinda has served on the AAUW California School Board Project Team since its launch last July. She provided an overview of the Team's work to support school board members who advocate for honest, inclusive public education statewide. Rebecca Radulovich, who retired after 34 years of teaching at Sunol Glen School, described persistent, heated dialogue among Sunol Glen School District Board members regarding the flying of the Pride flag. The controversy has culminated in a current effort to recall two of the three Board members.

DEI Around the Table: February 13, 6:00 to 7:30pm

The February DEI Committee meeting will be in person at Teresa Roeder's home. All branch members are welcome to attend. The agenda: AAUW's national DEI Team will conduct its monthly Zoom from 4:00-5:00 pm that day, so we'll begin our evening meeting with a quick review of the national call, followed by takeaways from the most recent statewide DEI call, after which we'll discuss "The Future of Academic Freedom", an article by Harvard Law School professor Jeannie Suk Gersen, published in The New Yorker on January 27, 2024. We'll examine the DEI challenges posed by free speech constraints that are causing widespread turmoil on college campuses and contributing to high-profile resignations including that of Claudine Gay (an AAUW Fellowship recipient) as the first Black president of Harvard University.

AAUW California Public Policy Update

Is There a Hidden Agenda Behind the "Parents' Rights" Movement?

We members of the AAUW California Public Policy School Board Project sub-committee frequently come across materials from groups advocating for book-banning, curriculum censorship, and policies which negatively impact the lives of LGBTQ+ students, in the name of "Parents' Rights." For example, the House of Representatives recently passed H.R. 5, the "Parents Bill of Rights Act." Eight governors have signed legislation with similar titles.

H.R. 5 establishes the rights of parents to, among other things: review curriculum; inspect the books and other reading materials in the school library; be advised of policies that permit transgender girls to compete on female athletic teams or use bathrooms or lockers designated for females; and provide consent before a school may use their child's chosen name or pronouns on forms, or change the child's sex-based accommodations. Many of the state laws noted above require the removal of "inappropriate" materials upon the objection of a single person.

AAUW California recognizes that not all our members will find these policies objectionable. And to be sure, most of our members would agree with this statement from PEN America, a human rights and free expression organization: "There is no question that parents deserve a say in shaping their children's educations; that they have a moral and legal responsibility for their children, and the freedom to make fundamental decisions for their families." (Suzanne Nossel, PEN America CEO, <u>Time Sept. 20, 2022</u>.)

However, legitimate questions are raised when one parent's "right" to control what *their* child reads and learns collides with another parent's right to ensure their child has access to a broad and diverse range of educational materials. Or when a parent's "right" to know if their child confides to a teacher regarding a sexual identity unknown to the parent collides with the student's right to privacy. Or when one parent's "right" to ensure her daughter doesn't play on the same team as a transgender girl collides with that girl's right to partake in all the same activities as other girls, or to feel safe in the campus environment.

AAUW California advocates for a diverse curriculum in our schools, as well as the protection of all forms of gender identity and expression. It is a cause of concern when the rallying cry of "parents' rights" is, as stated by PEN America, "wielded to do far more than give parents their rightful voice; it is turning public schools into political battle grounds, fracturing communities, and diverting time and energy away from teaching and learning." Additionally, according to the National Education Association (NEA), H.R. 5 "ignores the breadth of parental engagement" that already exists, "disregards educator experience and expertise" and "inserts the government into local decisions."

PEN America worries that the current emphasis on working with schools for the betterment of the child has been replaced with a parental focus on wanting to impose their personal beliefs — moral, religious, and/or political — on the entire education system. As an organization founded on the principal of expanding educational opportunities, we might all heed Suzanne Nossel's final words in her Time article: "The phrase 'parents' rights' may have a nice ring to it, but the agenda now afoot in its name should sound alarms for all those who care about the future of public education."

It's A New Legislative Season—Get Ready to Take Action!

In January and February, the Public Policy Committee will be hard at work evaluating new bills for our 2024 Legislative Agenda. The committee, in collaboration with our legislative advocate and coalition partners, will select and analyze proposed state-level legislation that reflects AAUW California's Mission and Public Policy Priorities. As the committee is working through the legislative review process in January and February, we invite you to reach out to let us know of any proposed California legislation that you think the committee should review. At the end of the review period, in early March, the committee will select 30 bills to prioritize. You will be able to review and follow these bills via our online bill tracker, which will be updated for our 2024 agenda in mid-March. These bills will be the basis for our ongoing education and advocacy work throughout 2024.

DAW Represents at the January SRVUSD Board Meeting



Fourteen DAW members attended the San Ramon Valley Unified School District (SRVUSD) board meeting on January 30. Barbara Blalock and Ogie Strogatz each gave thoughtful, impactful comments to represent our branch during the evening. All the members there made a great impression with their presence and with our new branch T-shirts!

Area AAUW Branch Reps Meet with Congressman DeSaulnier

Several DAW branch members and fellow Inter Branch Council members participated in an online meeting with Congressman Mark DeSaulnier on January 4. The meeting was organized and led by Asha Bajaj, our DAW liaison to the California Public Policy team.

The congressman has been a continuing champion of women's health and reproductive rights. Asha encouraged him to support National AAUW priorities, in particular the passage of the ERA, the Family Act to create national paid family leave, and the John Lewis Voting Rights Advancement Act. Our Co-president, Ogie, gave him an overview of our branch's monthly attendance at SRVUSD meetings and of the CA AAUW's School Board Project. Other topics brought up were the issue of "parents' rights" in education and CA AAUW's Gov Trek program.



The Congressman was supportive of all our priorities and talked about his work as Chair of the Education Committee. On an interesting note, he mentioned his collaboration across the aisle with some very conservative Republican members of the Education Committee.

He thanked us for all the advocacy and education we do as AAUW and mentioned that one of his mentors was a President of the Concord branch. He offered to stay in touch and bolster our efforts to support high-quality public education.

We had a very productive and informative meeting in just ½ hour.

Notes from the January Third Thursday Meeting

The Impact of Social Media on Girls: Challenges, Opportunities, and Support

We hope you were able to join the branch for our January 18 Third Thursday Member Meeting. We enjoyed an engaging presentation and group discussion led and facilitated by **Jamie Nuñez, Western Region Manager at Common Sense Media** on the challenges, opportunities, and ways to support girls affected by misuse of social media. We were a large group of parents, grandparents, educators, and administrators - our many branch members who attended as well as those who joined us from the greater community. Jamie helped us unpack the ever-changing, ever-present world of social media – how it impacts our children - especially girls!

There was much to discuss, and Jamie led the way with the latest research performed by Common Sense Media – the first of which was the impact of online interruptions, notifications, and pinging by our devices in our (and our children's) daily lives. These can be constant interruptions from various sources/apps. The result of these interruptions and disruptions in our lives, and especially in developing brains, can be very unhealthy.

Second, Jamie shared the need for parents to understand the apps that their children use and understand platform features that can keep our children tied to their phones. Find out what your children use. Do some research. Note: Common Sense Media provides reviews of all types of media – they're a great resource. Most important, work as a family unit to talk about use and agree on this together. What are the features the apps use to engage children? What motivators do the apps use to keep kids interested? Are these motivators healthy or unhealthy? What do the kids say about these things? Jamie encouraged us to

have conversations with our children. He shared several trending apps that are engaging youth today – some of which employ AI in their goal to find and keep new users and followers.

Third, the topic of privacy and protecting our children was high on attendees' list of concerns regarding social media misuse. Jamie addressed this and the importance of making sure safeguards are in place to block unwanted contact of our children. Again, know the nature of the social media they use and have conversations within the family about the value of privacy and about ways to avoid 'dangerous pitfalls' that may impact young or naive users.

Finally, on a profound and celebratory note, Jamie and Ogie Strogatz reported on the recent passage of AB 1394 -actively supported by both Common Sense Media and our branch and state AAUW Public Policy units.

AB 1394 requires a court to award statutory damages between \$1 million and \$4 million for each act of commercial sexual exploitation that social media platforms "knowingly facilitated, aided or abetted." Never before have social media mega-companies been held accountable for the impact of their products. It was great news and a positive way to end a lively and thought-provoking evening.

Walnut Creek Downtown Historical Walk with the Art and Garden Interest Group

Join the **Art and Garden Interest Group** on February 15 at 9:15am to learn some fascinating background about Walnut Creek. This easy, 90-minute Downtown History Guided Walking Tour on city sidewalks brings to life the early times and development of what has become a Bay Area destination city.
