Announcing the 2025 DAW Scholarship Recipients

The Local Scholarship Committee is pleased to announce the award of \$23,000 in scholarships to 11 local college women. Each awardee will receive a scholarship of \$2,000; one awardee will also receive an additional \$1,000 for the Creative Endeavors Scholarship. The ten awardees, combined under the DAW Community Local and Renaissance Scholarships, were selected by the branch's Local Scholarship Committee. The awardee of the DAW Single-Parent Scholarship was selected by Diablo Valley College. Congratulations to the 2025 AAUW DAW scholarship recipients!

AAUW DAW Community Local Scholarships

These scholarships are open to individuals who identify as women, will be at least juniors in the upcoming academic year, and have a minimum GPA of 3.0. Applicants must have attended high school in Danville, Alamo, or Walnut Creek, or currently live and/or work in these communities.

Maria Abreu Dennis is a transfer student from Diablo Valley College; she's still deciding which four-year college to attend given the acceptances she's received. She is majoring in Psychology and aspires to be a Marriage and Family Therapist. Maria lives and works in Walnut Creek.

Erika Braun is pursuing a Master's degree in Nursing at the University of San Francisco and plans to be a Registered Nurse. She has a Bachelor's in Human Developmental Sciences and General Biology from the University of California (UC) San Diego, graduating Cum Laude. Erika attended Monte Vista High School and lives in Danville.

Katja Friess is majoring in Food Science at California Polytechnic State University where she will be a junior next year. Katja plans to be an industrial or academic Food Scientist. Katja graduated from Las Lomas High School and resides in Walnut Creek.

Sandra Huntley is a Diablo Valley College transfer student and will be attending UC San Diego in the fall. She works in Walnut Creek. Sandra's major is Business Administration/Economics and she is a first-generation college student. She plans to be a business entrepreneur.

Olivia Radding attends Loyola Marymount University and has a double major in Dance and Marketing. She will be a senior in the fall. Olivia plans to be a professional dancer. In addition to the Community Local Scholarship, Olivia has been awarded a \$1,000 Creative Endeavors scholarship. She attended Monte Vista High School and resides in Danville.

Babora Soltys, a Walnut Creek resident, is a licensed and working Vocational Nurse. She is now pursuing a Bachelor's in Nursing at Gurnick Academy of Medical Arts to become a Registered Nurse.

Anata Tran, a Danville resident, will be attending UC Law San Francisco as a new graduate student in the fall studying International Policy. She is working towards her Juris Doctor and plans to become a lawyer. She recently graduated from UC Berkeley with a Bachelor's in Political Science and a minor in Human Rights.

AAUW DAW Renaissance Scholarships

These scholarships are open to individuals who identify as women, attend California State University East Bay (CSUEB), and participate in the CSUEB Renaissance Scholars Program for former foster youth or are Renaissance Scholars students graduating from CSUEB and entering graduate school at CSUEB or another accredited college/university in the fall of 2025. Students must be at least sophomores in the coming academic year and have a minimum GPA of 2.5.

Justine Overmyer, a CSUEB senior this coming fall, is majoring in Psychology. She attended Los Medanos College where she obtained an Associate for Transfer in Criminal Justice and Psychology. Justine plans to pursue a Master's in Psychology and become a School Counselor or Social Worker. She is a first-generation college student.

Johnnia Tanner will be a senior at CSUEB this coming fall where she is majoring in Criminal Justice. She attended Skyline College and received an AA in Psychology. Johnnia wants to become a lawyer specializing in family law or police brutality. She is a first-generation college student.

Macey Vasquez will be a senior at CSUEB majoring in Human Development with a concentration in Women Studies. She is a first-generation college student. Macey attended Woodland Community College and received an AA in Child and Adolescent Development. Her goal is to work for a non-profit organization that

provides social service resources to low-income families.

Catching Up with Past Renaissance Awardees

Two of the DAW Renaissance Scholarship awardees from last year, 2024, just graduated from CSUEB with their graduate degrees – Camisha Nettles received a Master's in Public Administration and Nicole Silliman received a Master's in Social Work. Our very first Renaissance Scholarship awardee from 2023, Ruth Clay, is currently pursuing her Master's at CSUEB.

AAUW DAW Single Parent Scholarship

This scholarship is open to any student who is a single parent enrolled at Diablo Valley College (DVC), has completed at least 12 units, and has a minimum GPA of 3.0. The application process and award selection are administered by the DVC Scholarship Program with funds provided by DAW.

Blanca Flores will be a sophomore at DVC this coming fall with plans to transfer to a four-year institution next year. She is majoring in Early Childhood Education and wants to be a certified elementary school teacher.

Blanca already has an AA in Criminal Justice from Carrington College.

Ann Willoughby and Ogie Strogatz, Local Scholarship Committee members, had the privilege of attending the Renaissance Scholars Program annual luncheon on May 2 to honor the current graduating class of Renaissance Scholars, scholarship recipients, and donors – like AAUW. Both DAW and San Ramon branches, each of which has a Renaissance scholarship, were in attendance. The theme of this year's event was "Reach for the Sky!"

The Renaissance Scholars Program Coordinator Roshawn Campbell is a strong partner with DAW. She noted "I am grateful for RSP's partnership with AAUW DAW and look forward to continuing to inspire dreams and change lives together!"

The love and admiration students feel towards Roshawn was expressed over and over when

The Renaissance Scholars Program at CSUEB, and similar programs at all 23 CSU campuses, is a testament to CSU's commitment to the success of underrepresented, disadvantaged students. DEI Update

MAPPING

Our session on May 7 was a deep dive into the state-mandated addition of one semester of Ethnic Studies as a required course for graduation from all California public high schools beginning in the 2025-2026 school year. The Ethnic Studies requirement had been discussed at the SRVUSD Board meeting on April 22, with the Board requesting more information and deciding to revisit the topic at its May 13 meeting. The discussion on May 13 was intense, with over 50 public comments, pro and con, from both students and community members. The Board voted 4-1 to in favor of the course, asking district staff to return this summer to report on modifications to respond to commenters' concerns, also asking staff to return with evaluative feedback on the course, potentially after the fall semester and definitely at the end of the 2025-2026 school year. Heartfelt thanks to all of our members who have been able to participate in our local school board meetings!

Coming up: an opportunity to take action regarding a topic on which we reflected earlier this year. Our observance of Black History Month included a discussion about Restrictions Apply, a 2021 documentary that explores the issues of racist covenants, conditions, and restrictions in California home title deeds.

The Contra Costa County Clerk-Recorder's office recently announced the launch of Mapping Prejudice

in Contra Costa County, a community-driven initiative to identify and map racially restrictive covenants and clauses that were inserted into local property records to keep people who were not white from owning or occupying property.

The county is doing this work in partnership with the Mapping Prejudice Project, a research team based in the University of Minnesota Libraries. This group has been working with communities across the country to map racial covenants since 2016. Contra Costa's new initiative will engage residents of the county to identify and transcribe the information necessary to put these now-illegal restrictions on a modern map.

Volunteers from all over the County are invited to take part in this important work. Training and access to a digital portal to examine historical property records that have been flagged by the research team at the University of Minnesota for review will be provided. These documents offer a powerful hands-on learning experience and create an opportunity for community dialogue about our history and the legacy of housing discrimination.

Quest Science Center Collaboration

DAW Enriches its STEM Portfolio by Collaborating with Quest Science Center

At its May meeting, the DAW Board approved a collaboration with the Quest Science Center to help bring fun, free, family-friendly, hands-on STEM programs to our local community by encouraging volunteerism of DAW members and Tech Trek alumni at the local Quest events and promoting event attendance. This collaboration enriches our STEM portfolio

and enhances our engagement and visibility in the communities that we serve.

Quest, a local non-profit located founded in 2017 and headquartered in Livermore, has a mission to inspire and nurture every day and lifelong STEM engagement by individuals of all ages. It is a leader in informal science experiences and outreach, forging strong partnerships and significant community engagement in our region. Quest is committed to fostering inclusion and creating a welcoming experience, so people of all backgrounds feel a sense of belonging and excitement in the exploration of science and technology.

Quest's largest, signature event is the annual, one-day Tri-Valley Innovation Fair held each April at the Alameda County Fairgrounds in Pleasanton. The Fair attracts some 60+ local technology innovators and educators who provide interactive STEM exhibits highlighting innovation in our region. Some 3,000 people annually, from families with small children to seniors.



Quest also hosts Science @ Stockmen's Park, a Saturday summer series of STEM events. More locally, Quest debuted at the annual San Ramon Valley Art & Wind Festival in May, and participates in the Danville Veterans Pop-Up Museum held annually over the Veterans Day weekend. Quest STEM education and outreach programs serve communities from Tracy to Danville to Castro Valley. More than 20,000 people attend Quest community events annually.

DAW will circulate information about volunteer opportunities for upcoming Quest events to branch members and Tech Trek alumni as they become available. It's simple to do, and it's fun to

enjoy the experience and volunteer with family and friends.

Renew Your Membership Before July 1 and Save!

In this chaotic world one thing is certain – costs continue to go up! Our dues support three parts of the organization: AAUW National, AAUW California, and the AAUW DAW Branch.

Members of AAUW California voted to increase the state portion of the dues effective **July 1.** The state dues have not increased for more than 10 years since they went from \$16 to \$20. The increase on July 1, 2025, will be from \$20 to \$30. In addition to the needed increase, AAUW CA has worked to keep costs down by making the following changes.

- Closed Sacramento office and moved office manager to home office
- Consolidated equipment and supplies to close storage unit
- Moved almost all leadership team meetings, Convention and Committee Day to Zoom

AAUW California Public Policy News

AAUW California Mobilizes to Advance Priority Legislation

AAUW California advocates came out in full strength on April 8th and 9th to participate in Lobby Days 2025. A total of 197 people representing 66 branches, including our Public Policy Interns and other college students, turned out to advance our priority legislation. 84 people came to Sacramento on April 8th to meet in-person with legislative offices; 104 people held virtual meetings via Zoom on April 9th; and 9 people met with district offices. Because many offices prefer to keep their calendars open until last minute, our committee worked furiously right up until the day of the event to

schedule meetings. Meetings were requested with all 120 legislative offices, and 94 meetings were secured. In other words, we met with 78% of all legislative offices - a record for AAUW California!

Unsurprisingly there were a few hiccups, but a vast majority of the meetings went off smoothly. While most meetings were with staff, ten of the meetings were with legislators. Reports from the teams indicate that all of the meetings were courteous and cordial, including those with offices who did not agree with some of our positions. Many teams were received with enthusiasm and gratitude for

AAUW's scholarships, activities, and programs such as Tech Trek. Some staffers expressed interest in joining AAUW, and one staffer generously shared information with our Public Policy Interns about a Fellowship program she participated in which ultimately led to her current job. Overall we successfully met with 94 offices to advance our key legislation and increase awareness about AAUW and all the things we do to advance gender equity.

We asked the legislative offices to support SB 771 and SB 418, and oppose AB 579. **SB 771 (Stern)** "Social Media Platforms Endangering Californians", sponsored by AAUW California, would hold social media platforms liable if their algorithms or AI aid or abet users to intimidate and threaten marginalized groups. **SB 418 (Menjivar)** "Ensure Equal Access to Care for All" would prohibit a health plan or a health insurance provider from denying coverage or denying benefits to a person based upon

their race, color, national origin, age, disability, or sex - including sex characteristics such as intersex traits, pregnancy, and gender identity. **AB 579 (Castillo) "Yaeli's Law"**, which we opposed, would prohibit parental denial of support for youth self-identity from being considered as child abuse and the basis for custody or removal decisions.

Our positions on SB 418 and AB 579 are protective of the rights of transgender people, meeting the challenges of the current moment. A number of the offices expressed support for our positions with empathy and personal stories about legislators' family members who are transgender.

Shortly after our Lobby Days event, we learned that AB 579 is dead. The bill was held in the Assembly Rules Committee and was not referred to a policy committee, effectively killing the bill. We quickly replaced AB 579 with AB 1098 (Fong) "Title IX and the California Sex Equity in Education Act" as our third "A" priority bill. AB 1098 would expand protections for pregnant graduate students and institute protections for pregnant undergraduate students, prohibiting postsecondary educational institutions from discriminating against a student based on their current, potential, or past pregnancy or pregnancy-related conditions.

We invite you to track the progress of our top 3 bills, and all of the bills on our Legislative Agenda, by viewing the <u>2025 Bill Tracking Report</u>. The report will continue to be updated as the bills move through the legislative process, so you can always check back to see the latest status.
