


- Economic security for all women

California Proposition 50 at a Glance

You may have seen or heard recently about California Proposition 50, a crucial measure on the November 4, 2025, Special Election ballot. Here's a quick rundown.

What is Proposition 50?

Prop 50 asks California voters whether the state should adopt temporary congressional district maps if other states redraw their maps mid-decade for partisan advantage. These temporary maps would apply only if other states redraw their maps, would be used only through the 2026–2030 elections, and would then expire after the next census-driven redistricting.

Why does Prop 50 matter?

Prop 50 preserves the state's ability to serve all Californians in the face of federal encroachment. Federal encroachment in California in 2025 has included many problematic federal actions, such as:

- Unwanted deployment of federal police and troops into our public parks and schools
- Unilateral defunding of valued research and educational institutions, based on their commitment to sound scientific inquiry, civil rights protections, and pluralism

These actions and the Project 2025 agenda (on which they are based) are highly unpopular in



California, across the United States, and among members of AAUW California. They present a significant threat to many of the things we care about, including AAUW CA's central mission and focus: advancing equity for women and girls.

We do not acquiesce to the prospect of our state operating in a federal system in which democracy is no longer functional, listing instead toward an authoritarian system that puts troops in our streets, that censors our speech, that erases historical facts, that does not rely on sound science in decision-making, that directly endangers the wellbeing of women and girls, and that dehumanizes

important and valued members of our communities.

Supporting Prop 50 is a nonpartisan move to preserve wider democratic norms in California, oppose Project 2025 implementation in California, and continue to advance AAUW California's mission and public policy priorities.

What is AAUW CA's position on Prop 50?

AAUW National has advised that, as an organization, AAUW CA is not able to make a formal recommendation about Proposition 50.

AAUW California has committed to present strong education-focused, nonpartisan messaging that emphasizes the potential benefits of Prop 50 for all Californians.

What do I need to do?

Hey there! Just a heads up that I will be sending out a solicitation letter this month for donations to AAUW, and I hope you will consider contributing to AAUW Funds. In the past five years, AAUW National has given away a whopping \$29.6 million to 1,538 women for fellowships and grants. This means we're helping more women shape the future in politics, company leadership, medicine, and beyond. And guess what? While we do appreciate those in our DAW branch who have given \$100 and more, even a small donation of just \$10 can make a big difference.

If you're interested in participating more directly in our AAUW National Funds process, we're looking for panelists to review applications for our various programs including Career Development Grants, Community Action Grants, International Fellowships, and Selected Professions Fellowships. Each panelist reviews approximately 10-20 applications and works with a partner to recommend awardees to AAUW. The reviews are done between December and February, and panel meetings are held in February and March.

Women's Political Leadership Conference at St Mary's - Highlights

The Women's and Gender Studies Program at Saint Mary's College hosted a well-attended, powerful one-day conference on "Women's Leadership in the Current Political Moment" on September 4. The conference was presented in collaboration with the Saint Mary's DEI Office and the AAUW Orinda Moraga-Lafayette Branch.

The program agenda included a lively, impactful, ethnically diverse panel with Berkeley Mayor Adena Ishii, El Cerrito Mayor Carolyn Wysinger, and Richmond City Council Member Claudia Jimenez, keynote speaker Gilda Gonzales, Outgoing President and CEO of Planned Parenthood Northern California, and concluding remarks by Barbara Lee, Mayor of Oakland.

A common theme expressed by the speakers was the need to be educated, engaged, and to work toward building community. They stressed the importance of women's political engagement and

leadership – women need to be at the table where they can change the conversion to focus on the needs of everyone, not just a select few. It is also important for younger people to engage in politics and take positions of power. And, by the way, sexism in politics is alive and well.

As one speaker indicated, "Be awake, active, and unapologetic." Community-level engagement is impactful, where local communities and organizations need to push back on the federal government. People also need to be aware and educated to be able to engage in organizations, commissions, campaigns, hosting parties, fundraising to advocate for women's rights which are human rights.

The conference was organized as part of Saint Mary's NEW (New Education for Women's) Leadership Institute, an academic summer program that teaches undergraduate women from across the Bay Area how to engage in politics, advocacy, and public service. Plans for a summer 2026 New Leadership Institute at Saint Mary's are in the works.

The Fight for Public Education Is the Fight for Democracy

The Public Policy Team is looking forward to another year of working with you to advocate for gender equity and social justice. As we kick off the new year, we are faced with many new challenges. Although this may feel daunting, we are using this moment to find new ways to work together impactfully. Our commitment to preserving democracy is unwavering, and we are grateful to have you as a partner in this fight. Because it may feel like you need to fight on all fronts, which can be

overwhelming, each month we will provide a list of targeted action items focused on a topic area that we care about.

This month our action items, and the articles in our newsletter, Public Policy News, are dedicated to the fight for public education as central in the fight to preserve our pluralistic democracy. We have also recently sent out content around getting out the vote (GOTV) in this year's special election in California, including providing information about Proposition 50 and a tool kit for taking action – check it out on our website at Public Policy - AAUW California.

Understanding the Urgency of Branch Participation in the Public Policy School Board Project

The constant noises that surround us today have had the effect on many of us wanting to "shut the door" and withdraw behind a protective shield. This is not an option if we want to protect our democracy and the rights declared in our Constitution. We must continue to protest against national policies that threaten our basic core principles, and take a stand at the state and local levels where we can have even greater impact. AAUW California's mission and public policies are being threatened, and we will not stand by and allow this to happen. Articles in our monthly AAUW California reports will present the specific violations of protected rights implemented by federal policies and local school boards throughout our state. Our advocacy and commitment to our public schools is critical, with a great deal at stake. Jefferson will end this discussion: "...Only educated citizens could make the American experiment in self-government succeed."

Anti-LGBTQ+ Supreme Court Decision Will Likely Impact K-12 Education in California

This June a decision was issued in *Mahmoud v. Taylor*, a case involving the LGBTQ+ community that was heard by the Supreme Court of the United States. Since it is a federal ruling, the outcome of this case may have an impact on the important legislative and on-the-ground work that AAUW California has been doing (via the School Board Project (SBP)) to protect historically accurate, diverse, and inclusive curricula in K-12 education and schools given the likely increase in legal opt-out requests by some parents.

This important case arose after the Montgomery County Public School (MCPS) Board, in Maryland, updated their curriculum in 2022 with more diverse and inclusive storybooks. They initially attempted to accommodate opt-out requests from parents from a coalition of religious groups who didn't want their children to read storybooks that included a normative portrayal of LGBTQ+ families.

The school board received such an influx of requests that course administration became unmanageable; the policy was costly for students, schools, and taxpayers. In addition, the influx of requests fundamentally "undermined the schools' educational obligations toward inclusion, equity, and respect" particularly relating to LGBTQ+ families' experiences. When the school board decided to end the opt-out option, parents filed this lawsuit.

The Public Policy Committee's **Proposition 50 and Get Out the Vote (GOTV) 2025 Guide** is a comprehensive toolkit comprising over 25 resources to support GOTV efforts, including a Pro 50 Messaging Guide, Overview, FAQ, Flyer, Election Timeline, and more. AAUW California members are encouraged to conduct GOTV outreach for the special election on November 4, 2025, to educate voters on the positive impacts of **Proposition 50** with reliable, nonpartisan information.

Normally, AAUW California publishes official recommendations to support or oppose propositions. However, AAUW National has advised that the organization not make a formal recommendation about Prop 50. Instead, the organization asks members to disseminate information-centered messages to increase awareness of the potential impacts of Prop 50 for all Californians and to encourage people to vote on November 4.
