

# **Public Policy, DEI, and Advocacy**

#### Update on efforts to dismantle the U.S. Department of Education

Per an article from the NPR KQED website, on 11/18/25 the "Trump administration unveiled a sweeping plan to sidestep Congress and outsource large pieces of the U.S. Department of Education, shifting work dedicated to, among other areas, elementary and secondary education, postsecondary education, and Indian education to other federal agencies." AAUW strongly disagrees with this direction. Gloria Blackwell, AAUW's CEO states in a recent press release: "When you hollow out the Department and scatter its knowledge of K-12 and higher education, you make it harder for students to challenge discrimination and harder for Congress or the public to hold parties accountable." #### San Ramon Valley Unified School District (SRVUSD) Topics

Herein, some thoughts on two topics that have come up recently in conversations with a number of DAW branch members.

1. Censorship and book banning concerns have surfaced regarding a recent authors' visit with some SRVUSD TK-third grade classes. The visit has been the subject of a good deal of reporting and commentary. The co-authors of the book, *The Day the Books Disappeared*, visited several SRVUSD elementary schools in October. The district subsequently was contacted by principals, faculty, and certified staff at the schools who stated that parts of the authors' presentation were not suited to the youngest learners in TK to third grade (4 years old to 9 years old) and extended beyond the students' developmental level. They did not have any complaints about the book.

Based on this feedback, district staff asked the organization coordinating the author visits to share the concerns about the presentation with the authors prior to their next SRVUSD school visit and request that the authors adjust their discussion to accommodate a young audience. The district staff received no response. When the authors arrived on the campus of Country Club Elementary School for their next school visit, the staff respectfully reiterated their request. The authors declined to modify their presentation and chose to leave without presenting.

DAW appreciates the district's demonstrated, consistent support for author visits and the inclusion of diverse books, perspectives and dialogue as meaningful educational opportunities for students. Grounded in <a href="AAUW CA's Public Policy Priority of equal access to quality public education -- including diverse curricula -- for all students,">students</a>, we acknowledge SRVUSD's unwavering commitment to provide engaging, age-appropriate learning experiences in the classrooms and on all campuses that reflect the best academic and social-emotional interests of the district's students, aligned with their developmental levels.

2. Several DAW members have inquired about AAUW's position on SRVUSD's grade reform plans. Because this topic is not within the scope of <u>AAUW CA Public Policy Priorities</u>, AAUW is not taking a position. That said, as community members it's important for us to stay informed about matters of active local interest. We encourage you to access the <u>Grade Reform Committee</u> content on the SRVUSD website to learn more about this important initiative.

#### **Excellent videos to inspire your advocacy**

AAUW National's 10/29/25 webinar, "Defending Equity: Standing Strong Against Attacks on Equity in Education", is available for viewing on YouTube; it's about 1 hour long. Moderated by AAUW CEO Gloria Blackwell, and featuring three AAUW fellowship alumnae and scholars, the webinar is rich with their insights, eloquence, strategies, and tactics.

A beautiful recorded arrangement of <u>Suffs' "Keep Marching"</u> by Shaina Taub (video is about 6 ½ minutes in length); Ms. Taub wrote the award-winning music, lyrics, and book for the musical, "Suffs", which is based on suffragists and the American women's suffrage movement.

### **November 20 Community Program - Recap**

For our November 20 Third Thursday Community Program, about 30 attendees learned about **The Reality of Reproductive Rights and Services in Contra Costa County.**

The featured speakers were Sarah McNeil, MD, with Contra Costa Regional Medical Center, and Christian Garcia, from Planned Parenthood Northern California (PPNorCal), who explored how women's health care, and particularly reproductive health, has evolved. Christian covered the wide range of health services offered by Planned Parenthood for both women and men, and both speakers noted the significant funding shortfalls about to take effect due to the recently passed federal HR 1 legislation (known as the Big Beautiful Bill). After short presentations, we had lively group discussions along with

engaging responses to questions from the attendees, all moderated by DAW Program Chair Bette Felton.

#### Key points we learned were:

- About ⅓ of all babies in Contra Costa are born at Contra Costa Regional Medical Center, our public hospital. About 50% of women delivering there have not had pre-natal care.
- Abortions make up only about 9% of the services provided by PPNorCal.
- About 40% of PPNorCal clients are male.
- A federal funding loss of over \$15 million is expected by PPNorCal and of \$270 million by Contra Costa County Health (CCH) due to cuts by the current administration. CCH is an integrated health care provider and includes: emergency care, the public hospital, mental health emergency, in and out-patient care, environmental health, public health and clinic visits at 6 satellite health centers, vaccines and infectious disease services, and more.

#### Suggested actions we can take are:

• Make efforts to educate others through thoughtful conversations based on "curiosity" about the critical role of Planned Parenthood in reproductive health care for both women and men.

- Normalize conversations on sexual and reproductive health with family and friends so people appreciate the importance of having appropriate care available to all.
- Donate to PPNorCal note that donations to national Planned Parenthood go toward lobbying efforts, while donations directed specifically to PPNorCal go toward services in our area.


# **AAUW California – Public Policy Updates**

#### **Supporting Public Education: Community-based Coalitions**

It began with one quietly determined advocate on a mission. Laurinda Ochoa, a Danville-based grandmother and retired attorney, was alarmed by the 2021 launch of Moms for Liberty chapters across California. In 2022 she began monitoring San Ramon Valley Unified School District (SRVUSD) board meetings, where she observed a swelling stream of demands from Moms for Liberty and their allies favoring restrictive and/or anti-LGBTQ+ curricula. Laurinda's desire to organize with like-minded local public education champions led her to join the Danville-Alamo-Walnut Creek (DAW) branch, where in 2023 she secured a strong commitment for branch representation at monthly meetings of the SRVUSD Board. Laurinda noted the organizations represented by other community attendees at the school board meetings. She nurtured relationships between our DAW branch and other groups who share AAUW's dedication to outstanding public education.

And she pressed on. Hearing DAW members' concerns about the challenges confronting school boards throughout the area, recognizing the synergistic political impact of multiple organizations speaking with a unified voice, and the potential for grassroots public education advocates across school districts to learn from one another through shared successes and challenges, Laurinda scaled up. She contacted the leaders of local pro-public education organizations to solicit their interest in forming a grassroots coalition that would serve as an additional source of support for public education across Contra Costa and Alameda Counties. The response was widespread enthusiasm. After several leadership planning meetings, the Lift Up Public Schools coalition launched formally in April, 2024.



Lift Up Public Schools (LUPS) is an all-volunteer coalition of grassroots groups from Contra Costa and Alameda Counties advocating for excellent public education delivered in settings that are safe and welcoming to all. LUPS has about 250 members including leaders from AAUW branches; PTA; Parents, Families, and Friends of Lesbians and Gays (PFLAG); the League of Women Voters; teachers unions; county and local partisan organizations; and current and former school district faculty and staff. The coalition is not funded by any political organization or entity. LUPS does not raise funds or make donations. The coalition's mission is to advocate for high-quality

public education that values diversity, equity, and inclusion. Its vision is a vibrant, democratic society of compassionate, well-informed, engaged community members.

LUPS initially focused on helping recruit, vet, and drive turnout to elect 2024 pro-public education school board candidates. The coalition supported 10 candidates running for seats in 8 Alameda County districts, 6 of whom won, and 6 candidates running for seats in 4 Contra Costa County districts, 4 of whom won. The coalition's support included social media promotion, assistance with the planning and conduct of candidate forums, and volunteering for candidate campaigns. In addition to electoral work, LUPS conducted community outreach to cultivate awareness, understanding, and action regarding the challenges facing public education; submitted public comments supporting diverse and inclusive ethnic studies curriculum; and endorsed a district parcel tax campaign. In the wake of the 2024 elections, the coalition has worked on capacity-building — evolving its organizational structure to stimulate the growth of LUPS local hubs in nearby school districts, expanding community outreach and education about the work of school boards, and developing as a trusted source of insight on the local impact of key public education-related issues at all levels of government.

As a LUPS organizer, I can attest to the value of our nascent coalition. We are growing compassionate grassroots power — holding a summit where presenters and the public exchange national, regional, and local perspectives on how best to respond to crucial challenges confronting public education; promoting outstanding school board candidates; publicizing local pro-public education initiatives; encouraging the development of local advocacy hubs; and leveraging the thousands of person-years of LUPS members' collective experience to help communities fulfill our highest aspirations for public education.

It can start with a single advocate – might be you!

# 2025 Legislative Session Ends with Some Big Wins and Tough Losses for AAUW California

The 2025 legislative session has closed in California.

Kathy Van Osten, AAUW California's Legislative Advocate, summarized the session this way: "In 2025, 917 bills were sent to the governor, of which he signed 794 bills and vetoed 123 bills. The 2025 Legislative Session was tumultuous as policymakers worked to address the impacts of ravaging urban wildfires in Los Angeles, to pass a state budget that closed a \$12 billion deficit, and to address a multitude of impacts created by the violent upheaval of federal funding and policies that have or will decimate services for Californians, that threaten existing or future projects in the State, and that threaten our educational institutions."

With these issues in mind, AAUW California put together our 2025 Legislative Agenda, taking a support position on 26 bills, and for the first time in our recent history, taking an opposition position on 7 bills. With the blessing of the Public Policy Committee and the AAUW California Board, we were proud to advance this agenda, which confronted some of the most pressing issues that we face as a state, and a nation, around gender equity and social justice. We were also proud to take strong opposition positions this year, given the large number of bills introduced at the start of the session that were antithetical to AAUW California's values and Public Policy Priorities.

While our A-priority support bills did not fare well this session, we are happy to report that we had a great deal of success with the rest of our support-bills as well as with stopping the opposition bills from advancing.

First the bad news: Our A-priority support bills were vetoed or gutted.

- SB 771 was vetoed. This A-priority bill, authored by Senator Henry Stern and sponsored by AAUW California, would have held social media companies liable if their algorithms aid or abet individual users who are breaking the law and intimidating or threatening others in online spaces. The Governor vetoed the bill, indicating that current civil rights laws have not been tested in the courts with respect to algorithms' complicity in hate crimes, and that until existing law is deemed insufficient by the courts, SB 771 is premature.
- **SB 418 was vetoed.** This A-priority bill, authored by Senator Caroline Menjivar, would have prohibited a health service provider from denying coverage for services based upon race, color, national origin, age, disability, or sex, including sexual preference or gender identity, intersex traits, and pregnancy. The Governor vetoed the bill, citing a concern that the bill's requirement to cover prescribed hormone therapy without utilization management (UM) is likely to drive up the cost of health care.
- AB 1098 was gutted and amended. This A-priority bill, authored by Assemblymember Mike Fong, would have prohibited a postsecondary educational institution from discriminating against a student based on their current, potential, or past pregnancy or pregnancy-related conditions. According to the author's office, the bill had run into significant opposition from the public universities, and they chose not to continue to move the bill this year. Instead, the bill language was gutted and replaced with language that establishes the Office of the Interagency Council on Education within the Governor's Operations Agency. The amended bill was signed into law.

**Now, the good news:** Of our fourteen support bills that made it to the Governor's desk, eleven were signed into law. Below are some important wins:

- AB 621 signed into law! This B-priority bill, authored by Assemblymember Rebecca Bauer-Kahan, heightens penalties for companies whose platforms distribute deepfake pornography.
- **SB 669 signed into law!** This B-priority bill, authored by Senate President pro Tempore Mike McGuire, authorizes up to five rural hospitals throughout the state to partner with licensed birth centers to provide perinatal services in rural communities.
- **AB 260 signed into law!** Authored by Assemblymember Cecilia Aguiar-Curry, this bill protects access to medication abortion.
- **SB 627- signed into law!** Authored by Senator Scott Wiener, this bill bans law enforcement officers from wearing facial coverings during their duties. **This is the first such law enacted in the nation!**

And of the seven bills that AAUW California opposed, four have become 2-year bills and three have died:

 AB 579 is dead! This A-priority bill, authored by Assemblymember Leticia Castillo, would have stated categorically that parents' refusal to acknowledge a child's gender identity can never be considered a form of abuse or neglect, and therefore cannot be considered in a custody dispute.

- AB 25 is dead! Authored by Assemblymember Carl DeMaio, this bill would have required an
  elections official to verify the citizenship of voters and authorized the official to require a
  person to provide documentation of citizenship for that purpose.
- **AB 1012 is dead!** Authored by Assemblymember Bill Essayli, this bill would have prohibited the provision of Medi-Cal to people without legal immigration status.

**Lilly, a film based on the life of Lilly Ledbetter,** premiered at the Hamptons International Film Festival on October 10, 2024, just two days before her passing. She was the pioneer of the Lilly Ledbetter Fair Pay Act of 2009, legislation signed by then President Obama to ensure all women receive fair pay for their work.

Ms. Ledbetter and AAUW had a long-lasting, strong, and productive relationship, and we held her in high esteem as an unwavering icon and trailblazer in the fight for equal pay. Together, Ms. Ledbetter, AAUW, and countless other organizations advocating for equal pay participated in marches, wrote letters, and sent emails which motivated Congress to pass the Lilly Ledbetter Fair Pay Act. Today, we continue her legacy by championing equal pay legislation such as the Paycheck Fairness Act, which would give workers new tools for ensuring that employers pay women and men equally for equal work.

From AAUW California's November Public Policy Newsletter – AAUW Showing Up!

At the Supreme Court: AAUW showed up. Our CEO, Gloria L. Blackwell, spoke at the rally on October 15, and our members were there on the steps. While some of the justices' questions were disheartening, it was powerful to see our community out in force. Check out the pictures of our members in this article.

**More layoffs? Maybe not**. AAUW signed a joint statement with disability, civil-rights, and education partners opposing harmful layoffs that would have gutted the Office for Civil Rights (OCR), the Office of Special Education Programs (OSEP), the Rehabilitation Services Administration (RSA), and the Office of Elementary and Secondary Education (OESE). On October 15, a judge temporarily blocked the administration from moving forward at most agencies and extended this to an indefinite block on October 28. Read more <a href="here.">here.</a>

**Opposing the Higher-Ed "Compact":** The administration's "Compact for Academic Excellence" ties funding to rollbacks of DEI and academic freedom. AAUW has joined a coalition letter urging presidents and trustees to reject the "administration's invitation to violate the law, abdicate your duty to your students and campus community, and betray academic freedom."
